Update on TIM Initiatives:

National/State/Regional

Rory Howe presented to the team about struck-by incidents and scene safety for first responders that respond to traffic incidents.

Why Responder Safety Comes First

- While in route:
 - ✓ Wear safety apparel prior to arrival / exit
 - ✓ Plan initial response / scene safety / safe exit

Why Situational Awareness Is Key

- When responding:
 - ✓ Confirm geographical location
 - ✓ Provide analysis of current situation
 - ✓ Detail actions required to mitigate the situation
 - ✓ Request resources required to support those actions
- As changes happen, update frequently:
 - ✓ Weather conditions change quickly
 - ✓ Lightning strikes twice
 - ✓ Ice, Hydroplaning, fog and low visibility
 - ✓ Blind curves, hills and obstructions
 - ✓ Path of initial crash is highly likely to reoccur
- The motorist's perspective:
 - ✓ Night and low volumes, motorists drive faster and do not expect to be stopped
 - ✓ Traffic control should meet MUTCD / FHWA SHRP2 training.
 - ✓ Adjust for weather / other issues
 - ✓ Adjust lighting / TTC for negative effects

Responder Safety First

- · No sudden movements
- Never turn your back on traffic
- Maintain eye contact with motorists
- Provide clear and concise directions
- Do not stand in traffic
- Develop an escape plan
- A healthy responder is a happy responder
 - √ 25% of Fire Fighter deaths due to vehicle strikes and traffic collisions

✓ More Law Enforcement officers injured by vehicle strikes than all other incidents (136 killed; '04-'13)

- · No driving or riding without a seat belt.

Chris Williams and Charles Stratton spoke to the team about the National Traffic Incident Management Awareness Week which will take place November 13-18, 2016. This is the first year that this event will take place and ideas to help promote the event was requested from the TIM members.

The goal of this week will be to raise awareness about the dangers emergency responders face on the roadway and to encourage drivers to be aware near incident scenes. The week will also be used to raise awareness among TIM professionals on the importance of being careful on the highway.

Chris Williams informed the team that the Florida Department of Transportation has launched a new website at http://fdot.gov/

Chris Williams informed that the Florida 511 is rolling out a new Application, with further expansion into 2017. The new company that has taken over the application will have rights to the current application look and will incorporate more user friendly options. New to Florida 511 is Drive Mode. Users can enter Drive Mode to get a quick view of local incidents and traffic speeds. Then, they are able to enter their destination and receive up to three routes with travel times based on current traffic conditions. Drive Mode also provides to the driver audible alerts of incidents occurring along their route.

Also, the team was informed that they are currently working on an expansion to the 511 Florida application to add the use of emergency evacuations, which would allow motorist to log onto the app and see updated information such as fuel vendors that may be running low on fuel etc.

Florida 511 features include:

- Drive Mode with interactive traffic map
- Up to three door-to-door routes provided per destination
- Travel times
- Real-time traffic conditions, including crashes, construction and closures
- Easily connect to the mobile website
- Traffic cameras
- Links to other travel or transportation related agencies

Chris Williams informed the team that a board is currently evaluating the Florida Administrative Code 15B-9 which contains the wrecker qualifications. The wrecker's qualification code was originally created in 1994 and has been a concern of the wrecker's community, as it is very outdated in certain regulations/requirements.

Chris Williams spoke to the team about the topic of the "First Responder Appreciation" awards which was discussed at the last TIM meeting that took place August 9, 2016. The award would recognize first responders that go "above and beyond" their duty while responding to incidents on the local highways. The responders would be nominated by their local agencies and a board of local TIM members would be created that would vote on the nominations.

The team stated that they will propose agency members at the next TIM meeting that will be a part of the board committee that will vote on the first responder nominations.

Chris Williams informed the team on the 2016 America's Transportation Awards Competition. The America's Transportation Awards competition is presented by the American Association of State Highway and Transportation Officials (AASHTO), and co-sponsored by the AAA motor club and the U.S. Chamber of Commerce.

The competition recognizes projects completed by state transportation departments that improve travel safety, reduce roadway congestion and provide more travel options to consumers. Projects are entered under three categories: Quality of Life/Community Development, Best Use of Innovation and Under Budget and grouped into three sizes: small for projects costing less than

\$25 million, medium for those between \$26 million and \$199 million and large for those costing \$200 million or more.

Traffic Incident Management (TIM) programs continue to play a vital role in the safe and quick clearance of traffic incidents while providing a framework for reducing congestion and maximizing use of existing transportation infrastructure.

A critical component of capitalizing on the success of existing programs and aiding the development of new TIM programs is periodic evaluation of the components of successful multi-agency TIM programs. The TIM Self-Assessment was designed to provide an easy-to-use tool for measuring TIM program performance. The team will be using the 2016 TIM Self-Assessment results as a tool to help identify 3-4 specific areas from the results that the team can concentrate on as goals for the upcoming year.
