

Collier – Lee - Charlotte Traffic Incident Management Team June 12, 2024 Meeting Minutes

<u>Call to Order</u>: The Collier-Lee-Charlotte TIM Team meeting was held on Wednesday, June 12, 2024, at 9:30 AM at the SWIFT SunGuide Center, 10041 Daniels Parkway, Fort Myers, FL 33913. Tom Arsenault and Brandy Boccuti facilitated the meeting.

DeAngelo Contracting Services (DCS) informed the team their agency has been holding internal meetings to discuss the increase in vehicles coming into the work area.

Florida Department of Environmental Protection informed the team they have a new hire which will help cover the area.

Update on TIM Initiatives:

Tom Arsenault, Metric Engineering, reminded the team about the purpose of the TIM Meeting.

- TIM is the coordinated detection, response to and removal of traffic incidents as quickly and safely as possible. TIM is a coordinated effort among multiple agencies.
- The primary purpose of TIM is to reduce the duration and impact of incidents as well as to improve the safety of motorists and most importantly our incident responders.
- The TIM Meeting is to help prop up the communication, coordination, and collaboration among our incident responders.

Stephen Boonstra, DeAngelo Contracting Services (DCS), presented to the team the 2024 Emergency Shoulder Use (ESU) and Hurricane preparation.

ESU is Florida's innovative strategy to increase traffic capacity during hurricane evacuations on key corridors within the state.

• Uses existing paved shoulders.

- Replaces former One-Way Plans, also known as contraflow and reverse laning.
- First used during Hurricane Irma in 2017.

- I-95 Corridor

David Burnside, TransCore, presented to the team the mock power outage test they are performing to help prepare for hurricane season.

Following Hurricane Ian, TransCore recommended several suggestions for response to disaster recovery. One such recommendation was to do a mock power outage test to determine ITS network vulnerability in a mass outage scenario. The mock outage simulation will test several components of the network including UPS functionality, network communications and device availability. This will also test generator utilization for (33) permanently mounted sites and portable generator deployment for a total of (83) power drops.

Test Objectives:

Following Hurricane Ian, there was a complete system outage affecting all devices. The objective of the mock outage test will be to reduce the initial impact of ITS device failures.

Following the test, TransCore will provide a Diagnostic Report to make recommendations for future improvements and improve network resiliency.

The Power Outage Test will be conducted in 5 Phases: Collier County, Lee County, Charlotte County, Sarasota County, Manatee County. The plan for conducting the phase tests will be as follows:

- Thursday, June 6, 2024 Phase 1
- Monday, June 10, 2024 Lessons learned, Follow up meeting from phase I
- Wednesday, June 12, 2024– Phase 2
- Friday, June 14, 2024 Phase 3
- Monday, June 17, 2024 Phase 4
- Tuesday, June 18, 2024 Phase 5
