Lee County Metropolitan Planning Organization informed the team that the Cape Coral Police are currently in training for the LiDAR Units to help with crash investigations.

Kevin Salsbery, FDOT, informed the team that they are currently preparing for the upcoming 2023 Hurricane season.

Update on TIM Initiatives:

Tom Arsenault, Metric Engineering, reminded the team about the purpose of the TIM Meeting.

- TIM is the coordinated detection, response to and removal of traffic incidents as quickly and safely as possible. TIM is a coordinated effort among multiple agencies.
- The primary purpose of TIM is to reduce the duration and impact of incidents as well as to improve the safety of motorists and most importantly our incident responders.
- The TIM Meeting is to help prop up the communication, coordination, and collaboration among our incident responders.

Aven Morgan, HNTB/D1 Regional Traffic Management Center, presented to the team on Freeway Operator Management Responsibilities.

Primary Responsibilities:

- Provide real-time travel-related information to the travelling public that helps them make informed travel decisions.
- Perform Traffic Incident Management related duties designed to clear the roadway as quickly as possible (< 90 min) in accordance with Florida's Open Roads policy.
- Coordinate Road Ranger service assistance to incident scenes such as crashes, disabled vehicles, debris removal and any other unplanned instances which impact traffic flow.
- Work with area maintaining agencies to optimize southwest Florida's roadway network.
- Ensure that Intelligence Transportation System devices are operating correctly.
- Assist in emergency operations.

- Mile Marker 101 southbound Exit Ramp
- Mile Marker 111 northbound Exit Ramp
- Mile Marker 141 northbound Exit Ramp

Common conditions in ramps surveyed:

- RPM's Missing/Broken/Non-Reflective
- Striping Deteriorated
- Thermoplastic Messages/Lead-In Lines Deteriorated
- Gore Markings need Refurbishing.
- Additional Wrong Way Signs Considerations
- No Right Turn Signs Considerations
