


Figure 2: RISC Events July 1 – December 31 Five Year Comparable

Responders: FHP, Manatee CSO, Road Ranger 111, Professional Towing, and DBI










Timeline:



Lessons Learned:

- This was a rolled over loaded scrap truck in the construction zone
 - Construction assisted in clearing the road.
 - No Injury
- Only 14 minutes between the crash and RISC Activation
 - Activated by Capt. Cardwell via Telephone with Tom Arsenault
- Good communication by the RR on scene to TMC via 2-way radio
- Good job by Professional towing getting on scene in required time (49 Minutes)


- Once on scene the 2 ramps effected were quickly cleaned up and the truck was back on its tires
- RISC Time 89 Minutes
- Total time 157 Minutes

11/20/2020

Lessons Learned:


- Good response times for on scene emergency equipment (11 Minutes)
- Responders included local P.D. going onto the interstate, something that we are trying to promote at TIM Meetings
- Importance to notify TMC/FHP the need for multiple wreckers
- Communication between TMC and DBI for the need for assistance was useful here in keeping traffic flow
- Activation to end just over 2 hours (126 Minutes)

11/21/2020

Southbound I-75, South of Clark Rd, Near Miler Marker 203 12:23 AM

Responders: FHP, Sarasota CSO, Sarasota EMS, and DBI

Lessons Learned:

- Early morning multi-vehicle crash
- · Responders arrived in 18 minutes
- Good radio communication with TMC & FHP
- Crashes at night are hard to evaluate via cameras, this requires the eyes on the ground to relay equipment needs, injuries, number of tow trucks etc.
- DBI notified via 24-hour communications
- All lanes open in under 2 hours
- Total time of all equipment 158 Minutes
