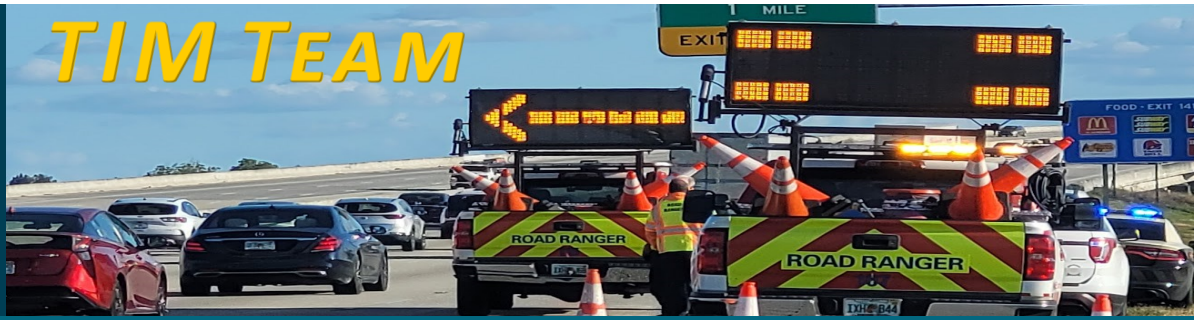

The Florida Highway Patrol (FHP) and local law enforcement will enforce the Super Bowl LIX impaired driving campaign, "Fans Don't Let Fans Drive Drunk," on February 9, 2025.

As first responders, your safety is paramount during one of the busiest nights of the year. Super Bowl Sunday brings an increase in impaired drivers, creating risks for those working to keep our roads safe. The U.S. Department of Transportation's National Highway Traffic Safety Administration (NHTSA) urges everyone to plan ahead: choose drinking OR driving, but not both.

Encourage your community to designate sober drivers, use rideshare services, or find alternative transportation to prevent impaired driving incidents. Your efforts save lives—both on the road and within your teams.

## Start the New Year with a Commitment to Traffic Incident Management

As we welcome the new year, it's time to renew our commitment to the safety of first responders and the traveling public. Recent incidents involving Road Rangers in District One highlight the critical need for Traffic Incident Management (TIM) and ongoing training to keep responders safe on our roadways.

Recently, District One has seen troubling incidents where Road Ranger trucks were struck. On December 21, 2024, a crash on I-75 tragically claimed a life. Fortunately, the deputy and Road Ranger were outside their vehicles and escaped with minor injuries.

On December 30, 2024, another incident occurred on Alligator Alley. While assisting a disabled vehicle, an Road Ranger truck was struck by a car traveling over 70 mph. The Road Ranger's quick thinking saved lives. He instructed passengers to stand behind the guardrail and he had to jump to safety himself. These events emphasize the dangers responders face and the lifesaving importance of proper training and adherence to safety protocols.

### SHRP2 Training: Free and Life-Saving

The National First Responder (SHRP2) Training equips responders with the tools and strategies needed to work safely and efficiently at incident scenes. This nationally recognized program focuses on reducing secondary crashes, improving on-scene safety, and enhancing interagency coordination. Best of all, we bring this training directly to local first responder agencies at no cost. Completing this training provides responders with actionable skills, improves safety for all, and strengthens partnerships between responding entities.

January is Move Over Month in Florida, a time to highlight the importance of the "Move Over Law." Recent Road Ranger incidents show why this law is vital to responder safety and underscore the need for public awareness and compliance.
