

# Heartland Counties Traffic Incident Management Team January 7, 2025 Meeting Minutes

**<u>Call to Order</u>**: The Heartland County TIM Team meeting was held virtually on Tuesday, January 7, 2025, 1:00 PM. Tom Arsenault and Brandy Boccuti facilitated the meeting.

**Introductions:** The team members provided their name and agency in the chat box for introductions and meeting attendance record.

Brandy Boccuti, Metric Engineering, kicked off the meeting by reviewing the meeting agenda and guidelines.

# Other Agency News

DeSoto County Fire Rescue thanked the TIM Team for the recent command training and emphasized the importance of continued collaboration between responding agencies during major incidents in rural areas.

Highlands County Fire Rescue expressed appreciation for the discussion around helicopter landing zone coordination and noted that their crews are focusing on response time improvements for remote crash locations.

Hardee County Sheriff's Office shared that they are working with FDOT on identifying recurring hot spots along SR 64 and SR 66 and plan to review crash trends with their traffic division.

FHP – Troop C and Troop F provided feedback on incident coordination and highlighted the importance of early communication during large-scale events. They also thanked the Road Rangers for their quick assistance during recent events.

Polk County Traffic Operations reminded the team of upcoming signal timing reviews taking place in Lake Wales and Winter Haven, and encouraged agencies to report any known intersection issues that could impact incident clearance.

#### Update on TIM Initiatives:

Tom Arsenault, Metric Engineering, reminded the team about the purpose of the TIM Meeting.

- TIM is the coordinated detection, response to and removal of traffic incidents as quickly and safely as possible. TIM is a coordinated effort among multiple agencies.
- The primary purpose of TIM is to reduce the duration and impact of incidents as well as to improve the safety of motorists and most importantly our incident responders.
- The TIM Meeting is to help prop up the communication, coordination, and collaboration among our incident responders.

Beau Baggett was introduced as the new Assistant TIM Program Manager supporting the Polk County TIM Team. Beau brings a strong background in transportation coordination and multiagency collaboration. As part of the Metric Engineering team, Beau will work alongside Program Manager Tom Arsenault and TIM Coordinator Brandy Boccuti to support incident management initiatives, facilitate meetings, and assist in growing regional TIM participation.

Beau shared a few words during the meeting, expressing enthusiasm for working with local agencies and contributing to efforts that enhance responder safety and reduce roadway incident impacts. The team welcomed him and looks forward to his involvement in future meetings and initiatives.

Tom Arsenault, Metric Engineering, presented to the team a training module for the January meeting, which focused on Command Responsibilities at the Scene of a traffic incident. The training emphasized the use of the Incident Command System (ICS) to ensure safe and coordinated response operations.

The topics reviewed included the following:

- The importance of establishing a Unified Command when multiple agencies are on scene
- The assignment and structure of ICS roles, including Incident Commander, Safety Officer, Public Information Officer, and Operations Section Chief
- The proper identification and use of staging areas for apparatus and personnel
- The necessity of an Incident Action Plan (IAP) for complex or extended-duration incidents
- Best practices for maintaining a clear chain of command and communication flow

Attendees discussed challenges seen in the field, including confusion over roles, scene crowding, and communication breakdowns. The training served as a reminder of the importance of early coordination, role clarity, and pre-planning to promote responder safety and traffic clearance efficiency.

After Action Reviews (AAR) provide agencies with actionable intel on an incident or event that can be used for improved strategies for future occurrences, demonstrating the benefit of quick clearance practices and improve cross-agency coordination and communication.
