<u>Call to Order</u>: The Heartland County TIM Team meeting was held virtually on Tuesday, July 11, 2023 1:00 PM. Tom Arsenault and Brandy Boccuti facilitated the meeting.

Brandy Boccuti, Metric Engineering, kicked off the meeting by reviewing the meeting agenda and guidelines.

## Other Agency News

Ray Mikol, SWIFT SunGuide Center, informed the team they are currently preparing for hurricane season. They are also currently focusing on Wrong Way Driver (WWD) systems in District One.

Law Enforcement informed the team that Operation Southern Slow Down will take place July 17-22. The joint effort is with the National Highway Traffic Safety Administration (NHTSA) and the southeastern states of Alabama, Georgia, South Carolina, and Tennessee. All five states and local law enforcement agencies will conduct a week-long speed enforcement campaign. FHP will specifically focus on detecting and citing drivers for exceeding the posted speed limits across Florida's interstate corridors.

# Update on TIM Initiatives:

Tom Arsenault, Metric Engineering, reminded the team about the purpose of the TIM Meeting.

• TIM is the coordinated detection, response to and removal of traffic incidents as quickly and safely as possible. TIM is a coordinated effort among multiple agencies.

Metric Engineering, Inc.

- The primary purpose of TIM is to reduce the duration and impact of incidents as well as to improve the safety of motorists and most importantly our incident responders.
- The TIM Meeting is to help prop up the communication, coordination, and collaboration among our incident responders.

Tom Arsenault, Metric Engineering, informed the team about the upcoming training for the National Traffic Incident management (SHRP2) Training which will take place July 13, 2023.

The training was developed *BY RESPONDERS* - *FOR RESPONDERS*, with the objective that nationally, responders acquire a common set of core competencies that promote a shared understanding of the requirements for achieving the safety of responders and motorists, quick response, and effective communications at traffic incident scenes.

Participants will receive a National TIM Responder Training certificate from the Federal Highway Administration (FHWA) after completing the training.

Tom Arsenault, Metric Engineering, provided a training session on Special Crash Circumstances. The presentation highlighted the following circumstances:

- Safety concerns related to responding to an incident involving a vehicle fire.
- Identify what hazardous material is being transported.
- Best practices for responding to an incident involving a vehicle fluid spill
- Primary goals of a crash investigation and the importance of preserving short-lived evidence
- Importance of performing response tasks concurrently as it relates to safe, quick clearance


